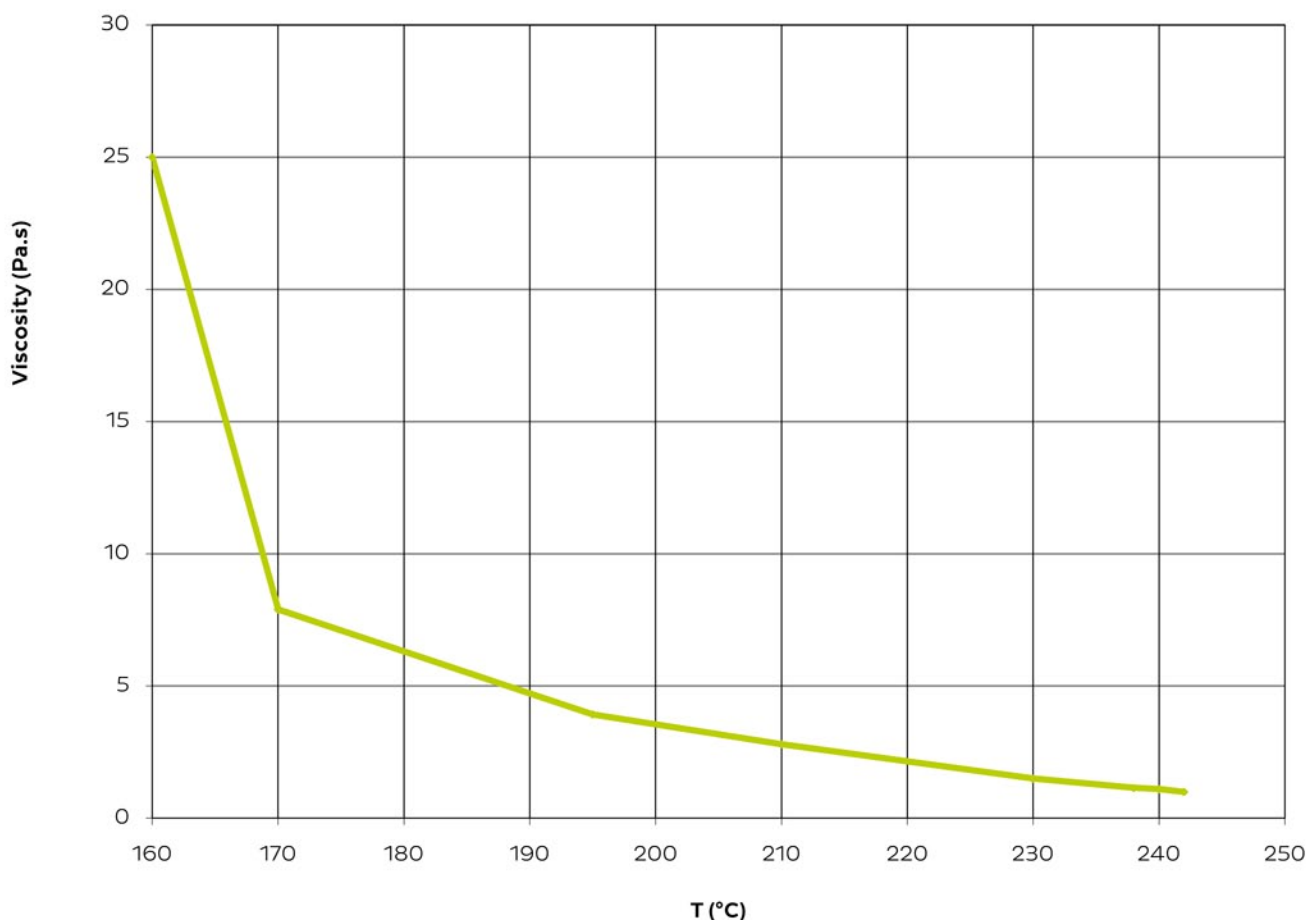

### STORAGE STABILITY

The product has a shelf life of 18 months when properly stored in a cool and dry location in closed original packing.

Thermelt 869 will absorb moisture from the air. Because of risk of moisture absorption, we highly recommend to store any open bag in a close container.
